This is with reference to this office letter of even number dated 17th September, 2019 and subsequent letter of even number dated 8th January, 2020 on the above mentioned subject. Reference is also invited to office memorandum No.AR-60/2016 dated Itanagar the 3rd February, 2017 whereby the Government of Arunachal Pradesh has decided to introduce "Chief Minister's Awards for Excellence in Public Administration" on the occasion of Civil Service Day on 21st April annually to recognize the extraordinary and innovative work done by the employees of the Government of Arunachal Pradesh.

1. All employees of the Government of Arunachal Pradesh individually or as a group or as an organization are eligible to be considered for the Awards. The number of Award in a year is 3 (Three) and the Awardees will be drawn from any field falling under the subject / Scheme as follows.

- i) Implementation of Innovative Schemes / Project;
- ii) Bringing in perceptible systemic changes and building up institution;
- iii) Making public service delivery systemic efficient and corruption free;
- iv) Showing innovation adaption to meet the stakeholders 'requirement';
- v) Extraordinary performance in emergent situations like floods, Earthquake etc;



- vi) Setting high standards of service and continued improvement, showing high Leadership qualities and improving employees' motivation etc.
- vii) Mission mode implementation of Schemes prioritized by Government of Arunachal Pradesh and announced by the Chief Minister of Arunachal Pradesh in his Budget.
- viii) Mission mode implementation of Government of India Schemes.

2. Two Awards shall be given in the individual category and one Award shall be given in the Organization / Team category comprising of Medal, a scroll and Award money of Rs. 1,00,000/- in case of an individual and Rs.5,00,000/- in case of Organization subject to maximum of Rs. 1,00,000/- per person in the team.

3. In this regard I am directed to inform you that the date of receiving nomination for Chief Minister's Award for Excellence in Public Administration,2020 has further been **extended upto 31st March (Tuesday), 2020.
